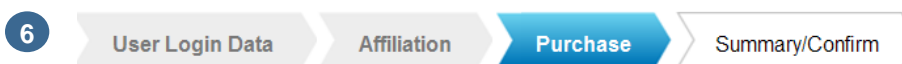


User/Login Data: Fill in the requested information and create your login. Only one person can be named on the registration. It's important to provide a valid email address — if you have one.

NOTE: please write down your ID and Password to log in again at a later time.



Affiliation: Here, you identify yourself as an employee (includes temp, vendor/contractor), volunteer, or parent. Then identify which parish, school or other type of location with which you're affiliated. Finally, identify your position at the Diocese.



Credit Card Purchase: \$9.50 for one license of the required course, Protect Children Part I: Predators & Abuse and Part II: Report Abuse. There are also optional courses you buy. If you want others to train, you can buy more course licenses, add users, and assign courses to them. If you buy more than one course for yourself or others, the price for each additional course is \$5.00.
